### Action items:

- The NERA Executive Committee has proposed changes to NERA's Rules of Operation. The changes will be forwarded to you tomorrow, consistent with the requirement that rule changes are shared with the Association at least 30 days prior to a vote by the Association. Be on the look-out for the email tomorrow.
- In a rather stunning turn of events, multistate projects submitted in NIMSS will no longer require NIFA approval. ([The correspondence from Mike Fitzner through Parag Chitnis and signed by Carrie Castille, August 6, 2021](#), is posted on the NERA website.) You'll recollect that prior to NIFA moving to Kansas City, approval of multistate projects by NIFA took up to 60 days. More importantly, the NIFA approval was duplicative of the reviews of our multistate projects by peers, by the Multistate Activities Committee (MAC) and by the Association. This places key decision making on multistate projects in the hands of the regions, where it belongs. To that end, NERA's MAC is seeking a new member to replace Eric Wommack, the new chair of NERA, come September 29. Do we have a volunteer?
- The Diversity Catalyst Committee of ESCOP will be issuing a "Call to Action" which seeks input from directors on actions that you are taking toward meeting the four challenge areas (recruiting and retaining a diverse workforce; strengthening partnerships among the 1862/1890/1994 institutions; addressing funding disparities across the three LGU systems; and working with underserved populations) identified during the 2020 ESS Meeting. Watch for the email from the Diversity Catalyst Committee Chair, Henry Fadamiro.
