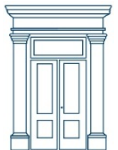


FY 2017/2018 Appropriations



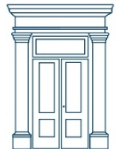
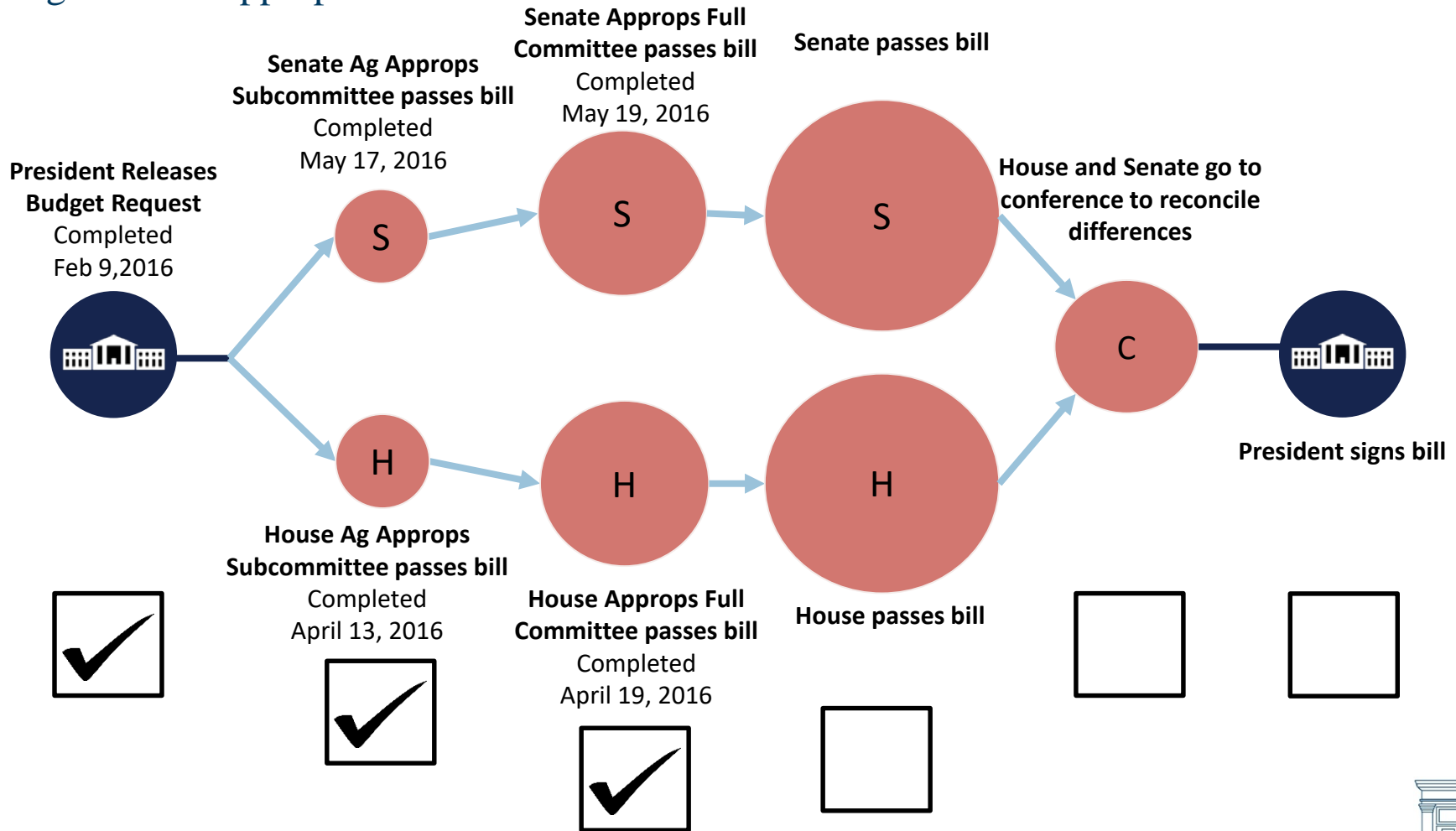
FY 2017 – Where we are now

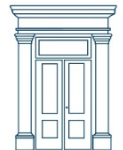
Agriculture Appropriations Bill

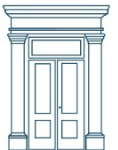

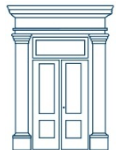
FY 2017 Completion

- If the numbers hold, our funding level will increase by \$25 million compared to FY 2016
- Perfect case-study for the single-ask approach – a unified system will have more success



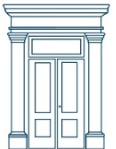
FY 2018 Budget Request

- President Trump has indicated he will release his budget proposal before April
- Early details:
 - \$54 billion increase in Defense
 - \$54 billion decrease in Non-Defense



APLU FY 2018 Priority

- Single-Ask: Increase NIFA by \$200 million in APLU's six priority lines



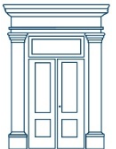

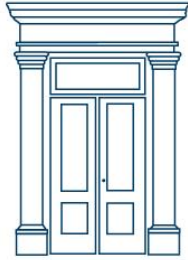
